


Information for Bidders

Bidding

The following means are available for placing bids:

- 1) Attending the Live Auction in Person: All bidders must register for a paddle, and new bidders must provide references at least three business days in advance of the sale.
- **2) Live Internet Bidding:** Instructions for participating as a Live Internet Bidder are provided on the page opposite.
- **3) Phone Bidding:** Bidders can be connected to the sale by phone and bid through a member of staff. Requests for phone bidding are subject to approval (please contact our office at least 24 hours before the sale). A signed Bid Form is required.
- **4) Absentee Bids.** All bids received in advance of the sale, either by mail, fax, phone, e-mail or internet, are Absentee Bids, which instruct the auctioneer to bid up to a specific amount on one or more lots in the sale. Absentee Bids sent by phone, fax or e-mail should arrive at least one hour prior to the start of the sale session. Bids entered through Live Internet Bidding will be visible to the auctioneer during the sale. Written bids should be entered legibly on the Bid Form in the sale catalogue. E-mail and internet bids should be carefully typed and double-checked. All new bidders must provide references. We recommend calling or e-mailing to confirm that Absentee Bids sent by mail, fax or e-mail have been received and entered.

Pre-Sale Viewing

Subject to availability, certain lots (except group lots) can be sent to known clients for examination. Requests must be made no later than 7 days prior to the sale. Lots must be returned on the day received. Postage/insurance costs will be invoiced.

In addition to regular viewing, clients may view lots by appointment. Our staff will be pleased to answer questions or provide additional information about lots.

Expert Certification

Individual items offered without a PF or PSE certificate dated within the past five years may be purchased subject to independent certification of genuineness and our description. Please refer to the Conditions of Sale and Grading Terms for policies governing certification.

Shipping and Delivery

Procedures and charges for shipping lots are printed on the back of the Bid Form. Bidders are responsible for all prescribed shipping charges and any applicable sales tax or customs duties.

Price Realized



Conditions of Sale (please read carefully before bidding)

The property described in this catalogue will be offered at public auction by Robert A. Siegel Auction Galleries, Inc. ("Galleries") on behalf of various consignors and itself or affiliated companies. By bidding on any lot, whether directly or by or through an agent, in person, or by telephone, facsimile or any other means, the bidder acknowledges and agrees to all of the following Conditions of Sale.

- 1. The highest bidder acknowledged by the auctioneer shall be the buyer. The term "final bid" means the last bid acknowledged by the auctioneer, which is normally the highest bid offered. The purchase price payable by the buyer will be the sum of the final bid and a commission of 15% of the final bid ("buyer's premium"), together with any sales tax, use tax or customs duties due on the sale.
- 2. The auctioneer has the right to reject any bid, to advance the bidding at his discretion and, in the event of a dispute between bidders, to determine the successful bidder, to continue the bidding or to reoffer and resell the lot in dispute. The Galleries' record of the final sale shall be conclusive.
- 3. All bids are per numbered lot in the catalogue unless otherwise announced by the auctioneer at the time of sale. The right is reserved to group two or more lots, to withdraw any lot or lots from the sale, or to act on behalf of the seller. The Galleries will execute bidding instructions on behalf of clients, but will not be responsible for the failure to execute such bids or for any errors in the execution of such bids.
- 4. Lots with numbers followed by the symbol ° are offered subject to a confidential minimum bid ("reserve"), below which the lot will not be sold. The absence of the symbol ° means that the lot is offered without a reserve. If there is no reserve, the auctioneer has sole discretion to establish a minimum opening bid and may refuse an offer of less than half of the published estimate. Any lot that does not reach its reserve or opening bid requested by the auctioneer will be announced as "passed" and excluded from the prices realized lists after the sale. The Galleries may have a direct or indirect ownership interest in any or all lots in the sale resulting from an advance of monies or goods-in-trade or a guarantee of minimum net proceeds made by the Galleries to the seller.
- 5. Subject to the exclusions listed in 5(A), the Galleries will accept the return of lots which have been misidentified or which have obvious faults that were present when the lot was in the Galleries' custody, but not so noted in the lot description. **All disputed lots** must be received by the Galleries intact with the original packing material within 5 days of delivery to the buyer but no later than 30 days from the sale date. (5A) EXCLUSIONS: The following lots may not be returned for any reason: lots containing 10 or more items; lots from buyers who registered for the pre-sale exhibition or received lots by postal viewing, thereby having had the opportunity to inspect them before the sale; any lot described with "faults," "defects" or a specific fault may not be returned because of any secondary fault. Photographed lots may not be returned because of centering, margins, short/nibbed perforations or other factors shown in the illustrations. Lots may not be returned for any of the following reasons: the color of the item does not match the color reproduction in the sale catalogue or website listing; the description contains inaccurate information about the quantity known or reported; or a certification service grades a stamp lower than the grade stated in the description.
- 6. Successful bidders, unless they have established credit with the Galleries prior to the sale, must make payment in full before the lots will be delivered. Buyers not known to the Galleries must make payment in full within 3 days from the date of sale. The Galleries retains the right to demand a cash deposit from anyone prior to bidder registration and/or to demand payment at the time the lot is knocked down to the highest bidder, for any reason whatsoever. In the event that any buyer refuses or fails to make payment in cash for any lot at the time it is knocked down to him, the auctioneer reserves the right to reoffer the lot immediately for sale to the

highest bidder. Credit cards (Visa, Mastercard and Discover only) can be accepted as payment but will be subject to a 3% Convenience Fee, which will be added to the total of the entire invoice (including hammer price, buyer's premium, shipping and transit insurance charges and any applicable taxes).

- 7. If the purchase price has not been paid within the time limit specified above, nor lots taken up within 7 days from the date of sale, the lots will be resold by whatever means deemed appropriate by the Galleries, and any loss incurred from resale will be charged to the defaulting buyer. Any account more than 30 days in arrears will be subject to a late payment charge of 1½% per month as long as the account remains in arrears. Any expenses incurred in securing payment from delinquent accounts will be charged to the defaulter. A fee of \$250.00 per check will be charged for each check returned for insufficient funds.
- 8. All lots are sold as genuine. Any lot accompanied by a certificate issued by The Philatelic Foundation or by Professional Stamp Experts within 5 years of the sale date is sold "as is" and in accordance with the description on the certificate. Such lots may not be returned for any reason, including but not limited to a contrary certificate of opinion. Buyers who wish to obtain a certificate for any item that does not have a P.F. or P.S.E. certificate (dated as above) may do so, provided that the following conditions are met: (1) the purchase price must be paid in full, (2) the item must be submitted to an acceptable expertizing committee with a properly executed application form within 21 days of the sale, (3) a copy of the application form must be given to the Galleries, (4) in the event that an adverse opinion is received, the Galleries retain the right to resubmit the item on the buyer's behalf for reconsideration, without time limit or other restrictions, (5) unless written notification to the contrary is received, items submitted for certification will be considered cleared 90 days from the date of sale, and (6) in the event any item is determined to be "not as described", the buyer will be refunded the purchase price and the certification fee up to \$600.00 unless otherwise agreed.
- 9. Until paid for in full, all lots remain the property of the Galleries on behalf of the seller.
- 10. Agents executing bids on behalf of clients will be held responsible for all purchases made on behalf of clients unless otherwise arranged prior to the sale.
- 11. The buyer assumes all risk for delivery of purchased lots and agrees to pay for prescribed shipping costs. Buyers outside the U.S. are responsible for all customs duties.
- 12. The bidder consents that any action or proceeding against it may be commenced and maintained in any court within the State of New York or in the United States District Court for the Southern District of New York, that the courts of the State of New York and United States District Court for the Southern District of New York shall have jurisdiction with respect to the subject matter hereof and the person of the bidder. The bidder agrees not to assert any defense to any action or proceeding initiated by Galleries based upon improper venue or inconvenient forum. The bidder agrees that any action brought by the bidder shall be commenced and maintained only in a Federal Court in the United States District Court for the Southern District of New York or the State Court in the county in which Galleries has its principal place of business in New York. These Terms and Conditions shall be governed by and construed in accordance with the substantive laws of the State of New York.

Grades, Abbreviations and Values Used in Descriptions

Grades and Centering

Our descriptions contain detailed information and observations about each item's condition. We have also assigned grades to stamps and covers, which reflect our subjective assessment. For stamps, the margin width, centering and gum are described and graded according to generally-accepted standards (an approximate correlation to numeric grades is provided at right). Although we believe our grades are accurate, they are not always exactly aligned with third-party grading terms or standards for all issues. A lot may not be returned because a certification service grades a stamp lower than the grade stated in the description. Information from the P.S.E. Stamp Market Quarterly and P.S.E. Population Report^{5M} is the most current available, but lots may not be returned due to errors or changes in statistics or data.

Extremely Fine Gem (90-100): The term "Gem" describes condition that is the finest possible for the issue. This term is equivalent to "Superb" used by grading services.

Extremely Fine (80-90): Exceptionally large/wide margins or near perfect centering.

Very Fine (70-85): Normal-size margins for the issue and well-centered with the design a bit closer to one side. "Very Fine and choice" applies to stamps that have desirable traits such as rich color, sharp impression, freshness or clarity of cancel.

Fine (60-70): Smaller than usual margins or noticeably off center. Pre-1890 issues may have the design touched in places.

Very Good (below 60): Attractive appearance, but margins or perforations cut into the design.

Covers

Minor nicks, short edge tears, flap tears and slight reduction at one side are normal conditions for 19th century envelopes. Folded letters should be expected to have at least one file fold. Light cleaning of covers and small mends along the edges are accepted forms of conservation. Unusual covers may have a common stamp with a slight crease or tiny tear. These flaws exist in virtually all 19th century covers and are not always described. They are not grounds for return.

Catalogue Values and Estimates

Unless otherwise noted, the currently available *Scott Catalogue* values are quoted in dollars with a decimal point. Other catalogues are often used for foreign countries or specialized areas and are referred to by their common name: *Stanley Gibbons* (SG), *Dietz, American Air Mail Catalogue* (AAMC), *Michel, Zumstein, Facit*, etc. Estimates are indicated with an "E." and reflect our conservative valuation in dollars. Reserves will never exceed the low end of the estimate range; they will sometimes exceed Scott Catalogue value for stamps in Extremely Fine condition.

Because of certain pricing inconsistencies in the *Scott Catalogue*—for example, blocks that have no gum, the absence of premiums for Mint N.H. items, etc.—we cannot guarantee the accuracy of values quoted for multiples, specialized items and collection lots. We generally try to be conservative, but buyers may not return a lot because of a discrepancy in catalogue value due to Scott pricing inconsistencies.

SOUTHN. LETTER UNPAID. Bold strike of two-line handstamp in blue, only the first word somewhat incomplete, matching "DUE 3" straightline and "Louisville Ky. Jun. 29" (1861) double-circle datestamp (date struck in error) on small cover to Brandenburg, Kentucky, initially entered the C.S.A. mails with "Salem Va. Jul. 2" circular datestamp and manuscript "PM at Louisville will forward this letter to Brandenburg", matching "Paid 5ct" C.S.A. rate at top left, some ink bleeding from the Louisville handstamps and the manuscript notation at bottom, part of top flap removed

FINE AND RARE EXAMPLE OF THE "SOUTHERN LETTER UNPAID" MARKING ON A COVER ADDRESSED TO KENTUCKY. ONE OF THREE RECORDED WITH THE INCORRECTLY-DATED LOUISVILLE DATESTAMP.

By Postmaster General Blair's order of May 27, mail service to disloyal Southern states was discontinued. On or about June 8, mail exchange between Louisville and Nashville was also banned. Starting June 13, the Louisville postmaster, Dr. John J. Speed, decided to hold the northbound mail received from Nashville, rather than divert it to the U.S. Dead Letter Office. Speed sent a request to Washington D.C. for instructions on how to handle the mail that was rapidly accumulating. Speed received instructions from the U.S. Post Office Department, which were wired on June 24, advising him to "forward letters from the South for the loyal states as unpaid after removing postage stamps..." Since it was impractical to remove stamps from all of the letters (although apparently that was attempted at first), Postmaster Speed created the "Southn. Letter Unpaid" marking to explain to the addressees that the U.S. stamps applied by the senders were invalid for postage.

This cover was mailed from Salem Va. on July 2 and arrived at Louisville on approximately July 5. However, the postal clerk applied the June 29 marking in error, neglecting to change the date slug in his handstamp. There are two other covers listed in the *Special Routes* census that also arrived after June 29 but received the June 29 datestamp.

A total of 29 "Southn. Letter Unpaid" covers are recorded in the *Special Routes* book (No. 25 has been deleted as a fake since publication).

A CLEARLY STRUCK "SOUTHN. LETTER UNPAID" HANDSTAMP ON A COVER FROM NEW ORLEANS TO CINCINNATI, FRANKED WITH THE UNITED STATES 3-CENT 1857 ISSUE.

The U.S. May 27 suspension order prohibited post offices from forwarding southbound mail to disloyal Southern states. However, northbound mail continued to be sent via Louisville. Through June 6, northbound mails were forwarded to Louisville from Memphis or Nashville. From June 7 through 12, only the Nashville post office forwarded mail to Louisville, and Louisville continued to forward mail north. With the resignation of W. D. McNish as Nashville's Federal postmaster on June 12 and the withdrawal of the U.S. mail agent from this route, Louisville held the mails still being sent north by the discontinued post office at Nashville. On June 24, Dr. John J. Speed, the postmaster at Louisville, was advised to forward letters from the South to the loyal states after removing postage. With approximately 5,000 such letters accumulating at Louisville by this date, Postmaster Speed employed a more practical means of invalidating postage by creating the "Southn. Letter Unpaid" handstamp.

United States postage stamps and stamped envelopes used from the South were regarded as contraband and were refused as prepayment. There are 29 "Southn. Letter Unpaid" covers recorded in the *Special Routes* book (No. 25 has been deleted as a fake since publication), of which only 13 have the 3c U.S. adhesive stamp used to attempt to pay the domestic rate. Two of the 13 are used with New Orleans provisionals. While this cover is missing its original New Orleans provisional stamps, it is still desirable with the boldly struck handstamp and the 3c 1857 issue.

VERY FINE AND ATTRACTIVE APPEARANCE DESPITE REPAIRS. THIS IS THE DISCOVERY COPY OF THE HYBRID RED AND BROWN ERROR, WHICH PROVES THAT THE 5-CENT RED COLOR ERRORS RESULTED FROM COMPLICATIONS IN MIXING INKS.

There is only one true color error among all Southern Postmasters' Provisionals: the New Orleans 5c Red, which is found on both White and Bluish papers.

In his 1978 *Congress Book* article, Dr. Hubert C. Skinner theorized that either "too much red ink was introduced onto the platen in blending the brown ink or the components of the ink separated while the press was idle for a time." This, he speculated, "produced a mottled impression on a very few sheets" and "would have been corrected as soon as the rollers passed across the platen a few times re-mixing or blending the ink." The discovery of the hybrid Red-and-Brown stamp (the stamp offered here) confirmed Dr. Skinner's theory. The ink mixture error had to have occurred more than once, because the stamps on White paper were printed in June, and the stamps on Blue paper were printed in August.

Our records contain the following examples of the 5c Red error: White Paper (62X6): 1) Unused with traces of gum, ex Ferrary, Hind, Brooks (not seen publicly since 1943); 2) "DUE (3cts)" straightline, partly rebacked over thins, ex Caspary, Lilly, Kilbourne and D.K.; 3) Cut in at bottom, tied by "Paid" straightline on part of cover to Mrs. Wm. Reynaud, Baton Rouge, photo by Hiram Deats in P.F. files; 4) Mixture of Red and Brown, corner strike of circular datestamp, partly rebacked over thins and tear, ex D.K., the stamp offered here; Blue Paper (62X7): 5) Dec. 4 circular datestamp, thin spots and small repair, ex Crocker, Felton and D.K.; 6) Sep. 17 circular datestamp, small faults, ex Ferrary, Hind, Lilly and D.K.; 7) Position 1, "Paid" and part datestamp, thinned with small nicks at left, ex Caspary, Dr. Skinner and D.K.

E. H. Cushing, publisher of the *Houston Daily Telegraph*, commenced his express service after New Orleans fell to Federal forces in April 1862. In an effort to improve communications between Texas regiments in the East and their relations at home, as well as secure safe lines for news transmission, Cushing established routes with pony riders and other means of conveyance necessary to cross the Federal lines. Cushing's agents affixed labels to the backs of envelopes carried by express. These were intended to inform patrons and advertise the service. Approximately 20 examples (of all varieties) are believed to exist. This type is much rarer than the larger labels.



The various catalogue listings for the 2c trial color proofs with framelines are somewhat confusing and not altogether complete. All of the known examples of the 2c Engraved essay/proof have framelines, unlike the issued stamp. For this reason they should be classified as essays. However, the Scott, Dietz and C.S.A. Catalogues list them as trial color proofs, and we have maintained that tradition here to avoid adding to the confusion. The Black offered here is listed in Scott Catalogue, which does not list the Blue, and makes no mention of framelines. The 1986 Dietz Catalogue listed this frameline proof in *Black*, but not Blue. The 2012 C.S.A. Catalogue expanded on Dietz and lists the Blue trial color proof with framelines (offered in this sale as lot 2319), but it eliminated this Black proof with framelines and describes the Black as "cut close no outer framelines showing" (an example of this is offered in lot 2320 — it shows two framelines).



Van Dyk MacBride illustrated four examples of the Confederate States Dead Letter Office oval in his 1944 *Congress Book* article. We record one other which is pictured in the *Special Routes* book on page 12. These five strikes (earliest dated Aug. 23, 1861) are on covers sent from the South to a Union state which were intercepted after the closure of mail routes and sent to the Dead Letter Office. The date in the Dead Letter Office oval indicates when it was released, rather than when it arrived.

This sixth example is the only known use on cover to a Confederate state. It is not clear from the datestamp when it was mailed, or whether it originated in a Confederate or a Union state (prior to June 1, 1861, it could have been either and been franked with U.S. stamps), but it is apparent from the "Advertised" marking that it found its way to the Dead Letter Office because it was undeliverable, rather than intercepted. It most likely contained money or other items of value.

Edward Benjamin Evans (1846-1922), known as "Major", was one of 19th and early 20th Century England's most distinguished philatelists, and a prolific philatelic writer. He was noted for his collections of Confederate States, as well as Mauritius (including his 1878 acquisition of the One Penny "Post Office" Mauritius cover addressed to Alcide Marquay, now in the British Library's Tapling Collection). His Confederate collection was purchased by Nassau Stamp Company's John Klemann about 1914. This composite proof was presented to him by De La Rue, printer of the C.S.A. typographed 6c and 1c stamps.





There are at least two unused pairs of the 10c Rose showing the imprint. Both have a portion of "Richmond" missing — one lacks the "M" and "N", while the other lacks most of the lettering after "RI" and is also partially severed and rejoined (ex Walcott, Caspary and Murphy, Siegel Sale 795, lot 745). Our review of old auction catalogues reveals that there may be another pair or another strip of four, but it is not clear if these entries duplicate one of the three examples described here. When the partially severed pair was sold in the Caspary sale it was described as "possibly unique." This strip is the largest imprint multiple we record and is particularly desirable as it shows completely each letter of the entire imprint. The second largest imprint multiple is the strip offered in the following lot.







As explained in the 2012 C.S.A. Catalogue, the lines on the Frameline issue were engraved on the copper printing plate as a means of aligning the die images as they were entered onto the plate. Because the framelines were shared by adjacent stamps, the norm is to find stamps with only a portion of some of the framelines. Stamps with parts of all four framelines are very scarce, while a stamp with four complete framelines which extend beyond the intersection of the lines is a rarity of the highest order. The Scott Gallagher collection contained a superb on-cover example with four complete framelines, though they do not extend as far as the example offered here. This stamp was described by Stanley B. Ashbrook in his review of the Newbury collection as "the finest used copy of the 1863 Confederate Frameline stamp in existence."





Wade Keys was Assistant Attorney General and twice served as Acting Attorney General, in 1861 and from 1863-64, during vacancies of the permanent appointees.

A cover from the Confederate States to England would typically be sent via a blockade runner (accompanying P.F. certificate calls it a blockade cover, in error). However, this was clearly sent by flag-of-truce via the Richmond-Old Point Comfort route. It may have been a prisoner-of-war cover sent by a Union prisoner in a Confederate prison, but it lacks any censor or prison notations.

A FINE AND RARE COVER FROM A UNION PRISONER HELD IN A CONFEDERATE PRISON CAMP IN TEXAS, SENT VIA THE SHREVEPORT-NEW ORLEANS FLAG-OF-TRUCE ROUTE. FEWER THAN TEN COVERS FROM CAMP FORD ARE KNOWN.

The Federal occupation of Baton Rouge on May 12, 1862, left the U.S. in control of southeastern Louisiana. The close proximity of U.S. and C.S.A. forces in Louisiana led to flag-of-truce prisoner and P.O.W. mail exchanges in 1863 to 1865. The principal exchange point was along the Mississippi River between U.S.-controlled Red River Landing and C.S.A.-controlled Simmesport. Most of the northbound mail has manuscript examined markings by Major Hyllested, Provost Marshal General of Texas at Houston, or, in the case of this cover, by Major Szymanski, Assistant Agent of Exchange for the Trans-Mississippi Department at Shreveport, Louisiana. The few surviving northbound covers are inner envelopes from C.S.A. prisons which were routed via Shreveport, Simmesport and Red River Landing to enter the U.S. mails at New Orleans. This is one of the finest in terms of overall condition.

VERY FINE. A FASCINATING COVER FROM THE WELL-KNOWN REYNES CORRESPONDENCE THAT WAS SMUGGLED OUT OF NEW ORLEANS AND POSTED AT CHARLESTON.

The Emile H. Reynes correspondence is famous for covers smuggled out of New Orleans and carried to their destination by various means, including by the Louisiana Relief Committee. The correspondence was discussed at length by Leonard Huber in a 1951 *American Philatelist* article. This cover was discussed in a 1993 *Confederate Philatelist* article by Conrad Bush, which also translates the letter, written in French, about the birth of Reynes's son (copy included).

The Charleston datestamp on this cover has convinced previous owners that it entered the city by blockade runner, and that conclusion is also reached in the Bush article. However, the port of Charleston was closed to blockade running between September 18, 1863, and March 4, 1864, due to the Union occupation of Morris Island and the subsequent mining of the harbor by the Confederacy. In addition, the letter states "I will pass this letter on to Mrs. B, who will add it to the one she will write to her glorious husband." Mrs. B was the wife of Confederate General P.G.T. Beauregard, who was then in charge of Charleston defenses. This letter was entrusted to Mrs. Beauregard, who sent it in a package — most likely via the Louisiana Relief Committee — to Charleston. It was mailed from Charleston to Augusta, care of Amedee Guyol, with insufficient postage. Research by Gene Hastings on other letters in the correspondence backs this interpretation. We are grateful to Steven C. Walske for his interpretation.



FINE. A RARE INCOMING BLOCKADE-RUN COVER FROM LT. JOHN M. KELL, FIRST OFFICER OF THE FAMOUS COMMERCE RAIDER C.S.S. *ALABAMA*, TO HIS WIFE IN MACON GA. THE *ALABAMA* CLAIMED 65 PRIZES DURING THE CIVIL WAR BEFORE BEING SUNK BY THE U.S.S. *KEARSAGE* ON JUNE 19, 1864.

Lt. Kell and most of his shipmates, including Captain Raphael Semmes, survived the sinking of the *Alabama*. According to Wikipedia, "During her two-year career as a commerce raider, *Alabama* caused disorder and devastation across the globe for Union merchant shipping. The Confederate cruiser claimed 65 prizes valued at nearly \$6,000,000... in 1862 alone 28 were claimed...Ironically, a decade before the beginning of the Civil War, Captain Semmes had observed: '(Commerce raiders) are little better than licensed pirates; and it behooves all civilized nations [...] to suppress the practice altogether.'" VERY FINE. A RARE USE OF A CONFEDERATE STAMP ON AN INCOMING BLOCKADE-RUN COVER FROM ENGLAND AND AN EXTREMELY UNUSUAL ENTRY POINT FOR BLOCKADE-RUN MAIL.

Irish-born John William Mallet was a chemistry professor at the University of Alabama. He enlisted as a private in a troop of C.S.A. Cavalry, but almost immediately was chosen as aide-de-camp on the staff of General Robert E. Rodes. He was transferred to the artillery in May 1862 and by 1865 became lieutenant-colonel and then superintendent of the C.S. Army ordnance laboratories.

Another cover addressed to Mallet in the same hand is shown on page 135 of the *Special Routes* book. It is the only recorded blockade-run cover with Savannah as the entry point (May 7, 1862). The cover offered here, with the same handwriting, has the "Ship Letter" and "Southern States" written notations and, therefore, must have originated in England.

The U.S.S. *South Carolina* initiated the blockade of Galveston on July 2, 1861. The first arrival of a steamship was on December 29, 1861, from Havana, Cuba. U.S. forces occupied Galveston Bay from September 30, 1863, to January 1, 1864, so no blockade running occurred during that period.

Fewer than ten incoming blockade covers are known, all postmarked in Houston, Texas, between January 29, 1864, and March 1, 1865. The surrender of Galveston on June 2, 1865, ended all blockade running. All known incoming blockade-run letters were carried under cover and posted by a forwarder in Houston with 10c C.S.A. postage prepaid, unless the letter was addressed to Houston. A forwarder marking from Havana or Mexico, or a dateline or docket from outside of the C.S.A., are identifying characteristics, along with a Houston postmark. Since the mail was carried under cover, no "ship" markings were used and the 2c ship fee was not assessed. (Special Routes book p. 261). This cover was carried on the Zephine from Havana.


