Boyd's A letter from France and "forwarded" by a private firm whose handstamp appears on back of the cover. Postage was high, so it was evaded as much as possible. The forwarder, in Paris, awaited a chance to give it to a ship captain or officer, who on arrival in N.Y., handed it over to Boyd for local delivery by one of his carriers. Note the cover, on face, shows traces of several more blue impressions of Greene & Co's handstamps indicating the sending of letters must have been considerable in that "consignment".
