REV. ISAAC P. COOK, A BOOKSELLER IN BALTIMORE FOR MANY YEARS, PROBABLY WAS NOT THE OR-
 GANIZER OF COOK'S DISPATCH, BUT MAY WELL HAVE BEEN THE FATHER OF ISAAC COOK, THE PRO-
 PRIETOR OF THE POST. REV. COOK WAS REGISTER OF WILLS OF THE ORPHAN'S COURT IN BALTI-
 MORE FROM 1858 TO 1868. THE ABOVE ACCOUNTING OF AN ESTATE BEARS COOK'S ATTESTA-
 TION AND A REVENUE STAMP CANCELLED BY HIS CIRCULAR HANDSTAMP, SEPT. 3, 1863.
