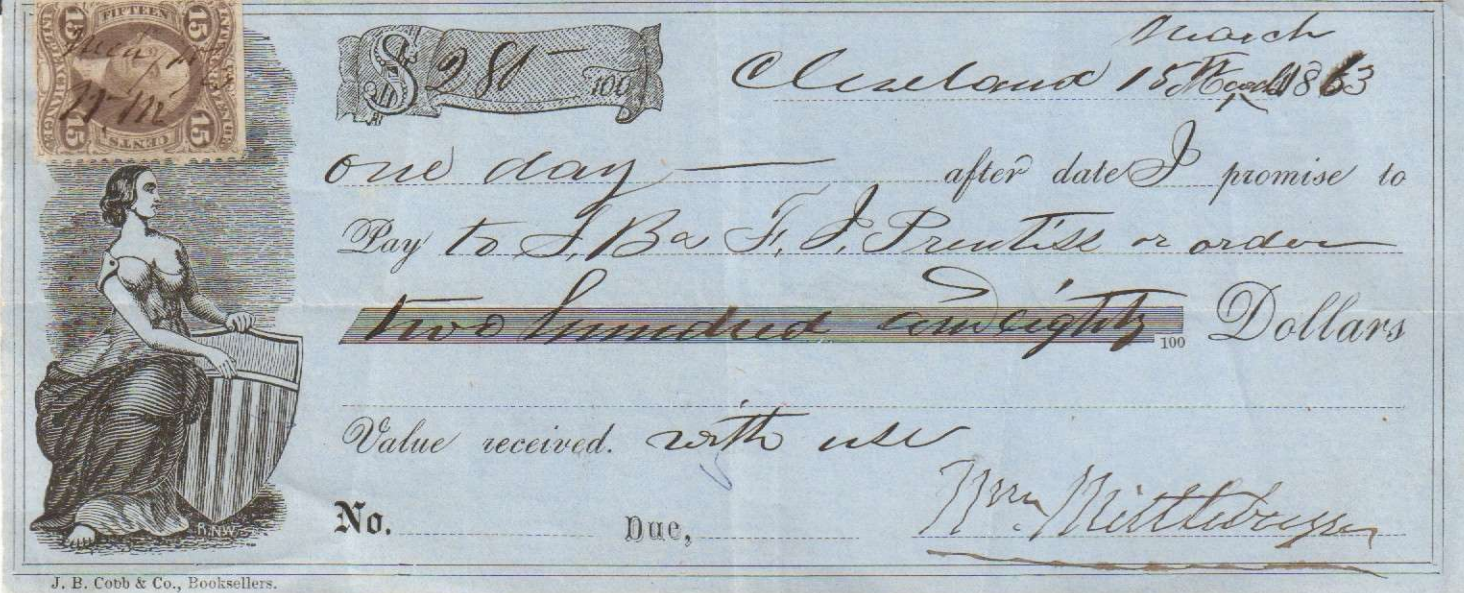

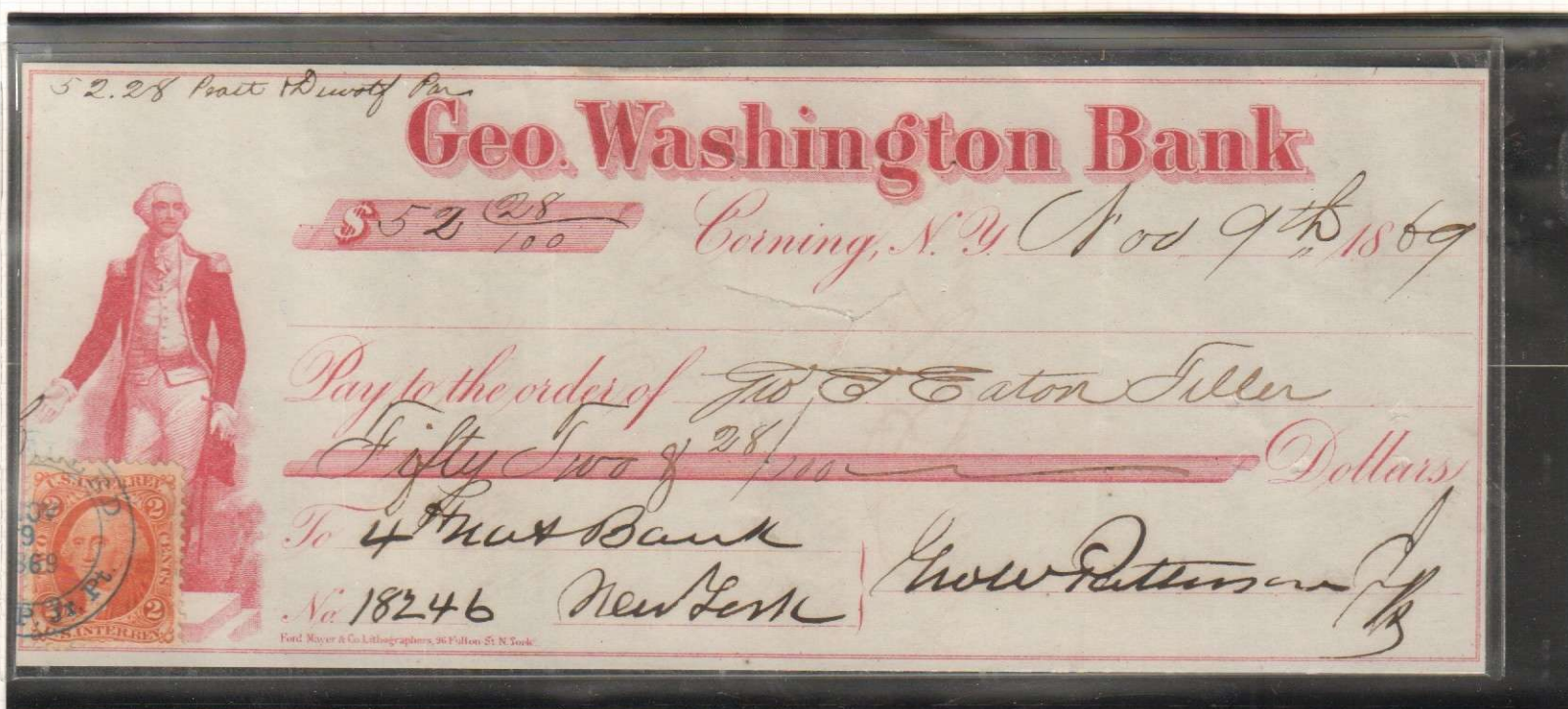

Up to Dec. 25, 1862 it was compulsory to use Revenue stamps for the purpose printed on the stamps; that is, Bank Check was for use on checks, Playing Card was for use on packs of Playing Cards, etc. After that date Revenue stamps were used indiscriminately, Playing Card stamps were used to pay the tax on checks, Express stamps were used on Promissory notes, etc., and when business firms ran out of Revenue stamps, they used Regular Postage stamps as Revenue stamps. Below are shown a few of these Postage issues used on checks to pay the Revenue tax.
