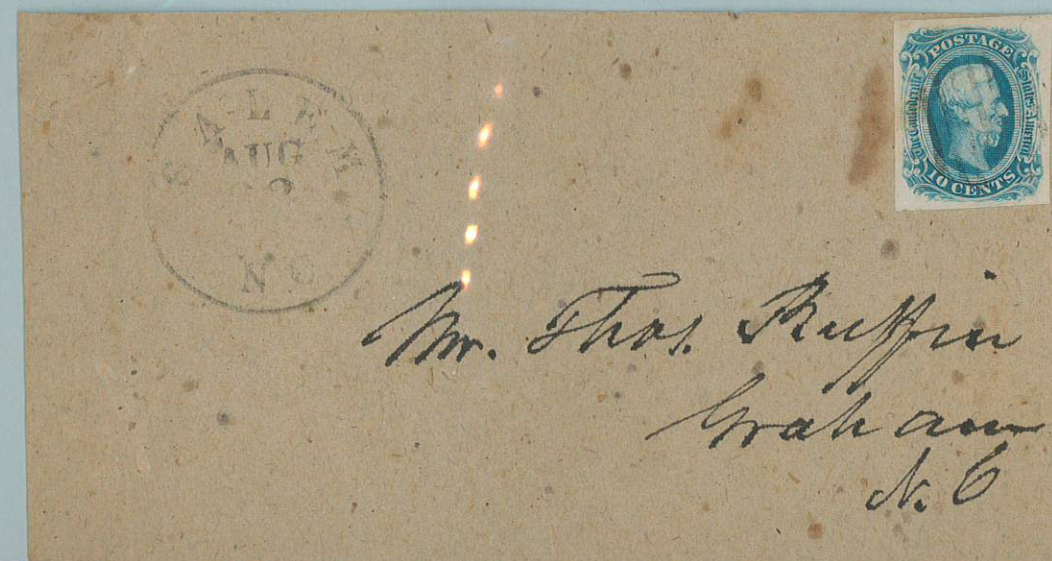
CONFEDERATE SC #11 USED ON HOMEMADE

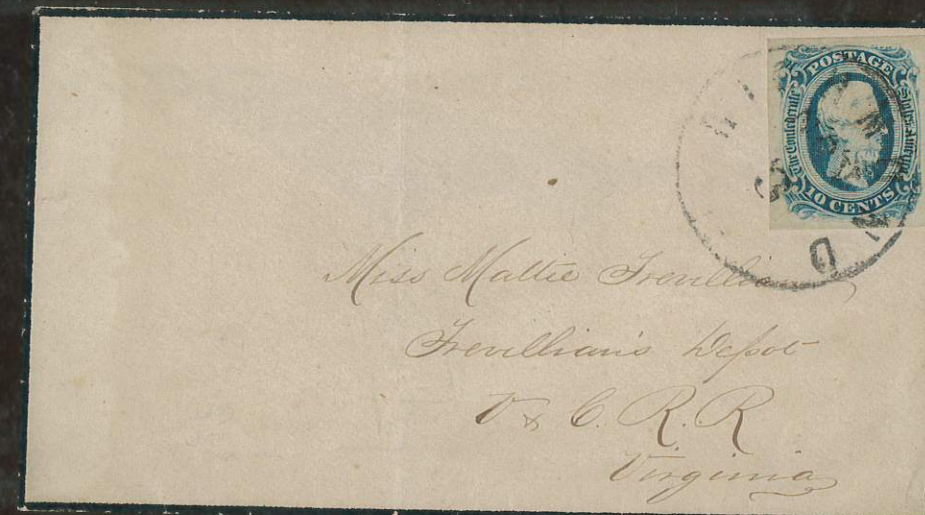

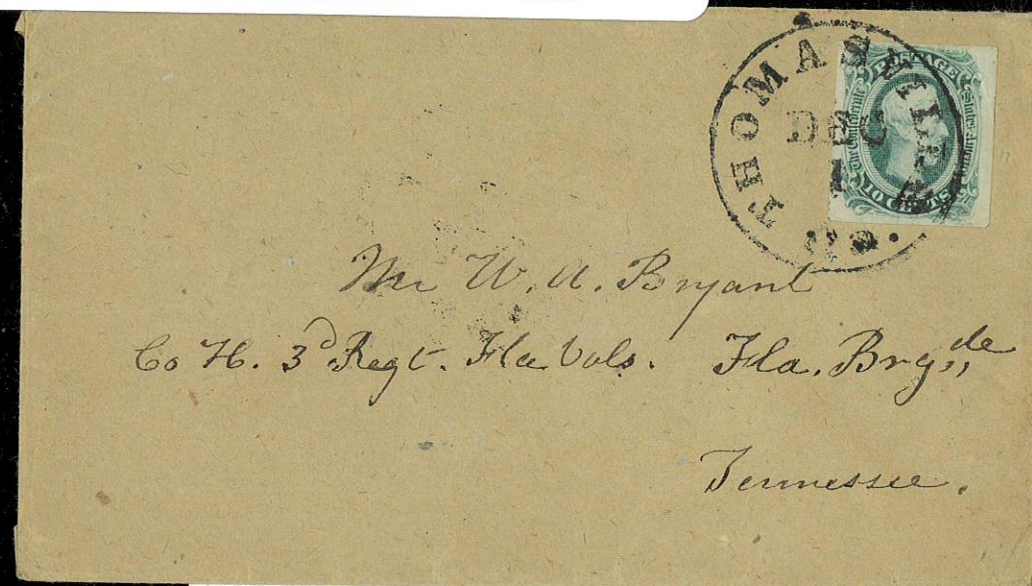
