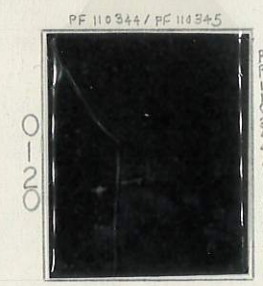

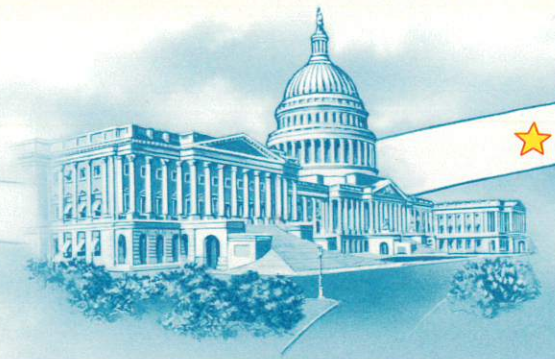

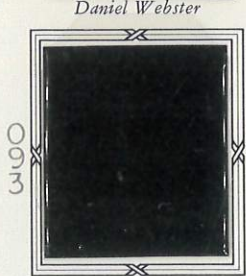
Official stamps were later replaced (May 1, 1879) in favor of penalty envelopes and on July 5, 1884, were declared obsolete.
