





Unlawful to hunt for any kind of game or fish without first procuring and having on one's PERSON a license as prescribed by law.


Lake, Sevier River below its junction with Clear Creek near the mouth of Sevier Canyon, Green River below the bridge on the Victory Highway, Duchesne River below its junction with Strawberry River, Bear River below the Cutler Dam, Weber River below its junction with Ogden River, Minersville Reservoir, Colorado River, and San Juan River at all seasons of the year.

DEER: October 18 to 28. One male deer with norns not less than five inches in length. Boys under sixteen not permitted to hunt deer. Red cap necessary.

OPEN SEASON ON PHEASANTS, SAGE HEN, PINE HEN, RUFFLED GROUSE, QUAIL, AND MOURNING DOVES: With limits, declared by Commissioner.
