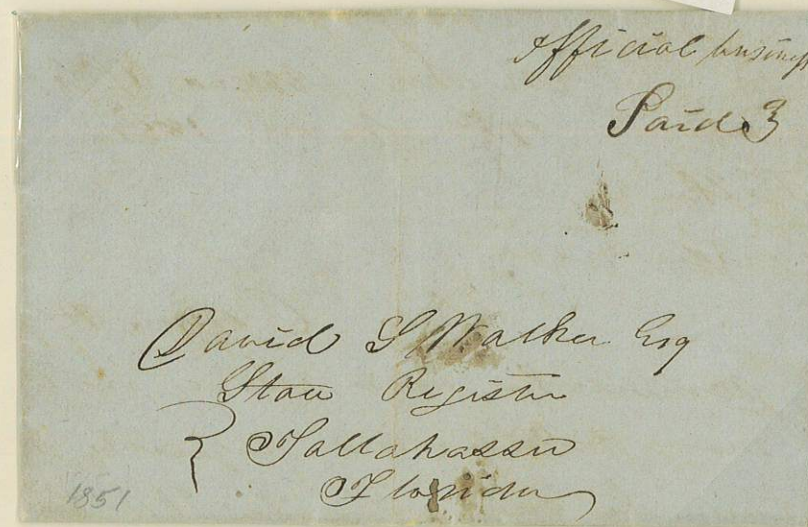

(UCHEE ANNA)

STATEHOOD

WALKER, David Shelby, jurist, gov. Fla.; b. Russellville, Ky., May 2, 1815; s. David and Mary (Barbour) W.; studied law with brother, George Walker; 1837-circa 1840; m. Phillice Alston, May 22, 1842; m. 2d, Elizabeth Duncan; 5 children. Admitted to Fla. bar, circa 1840; mem. 1st Tallahassee (Fla.), 1848; mem. Fla. Ho. of Reps. from Leon County, 1848-49; register of public lands, ex-officio supt. schs., 1850-59; asso. justice Fla. Supreme Ct., 1859-65; gov. Fla., 1865-67; see, July 20, 1891; buried Episcopal Cemetery, Tallahassee.



No postmark, endorsed official business.

Dateline, Euchee Anna, Florida, Nov. 17, 1851,
this post office existed, 1841-45, not known thereafter.

Addressed to David S. Walker, registrar of public lands,
governor, 1859-65, regarding purchase of land at \$1.25 per acre.

Marked paid 3, for up to 3000 miles.
